Macluumaadka Maaliyadeed

- Warbixinta Maaliyadeed ee Shakhsiyeed (codsade walba, damaanad qaade walba, iyo mulkiilaha ee ka leh dan ah 20% ama ka badan ganacsiga)
- Warqadda dheelitirka ee hadda jira
- Warbixinta faa'iidada iyo khasaaraha sanad-illaa-hadda
- Soo celinta canshuurta ee ganacsiga ee 3-dii sano ee la soo dhaafay
- Saadaalinta dhaqdhaqaaqa lacagta caddaanka ah ee bil walba ugu yaraan muddo hal sano ah
- 3dii sano ee la soo dhaafay ee canshuur celinta shakhsiyeed ee codsade walba, damaanad qaade walba, iyo mulkiilaha ee ka leh dan ah 20% ama ka badan ganacsiga. **OGOW:** Waxaa la filayaa in dhammaan milkiilayaasha leh 20% ama ka badan ee saamiga lahaanshaha ay bixin doonaan dammaanad shaqsiyeed.

Codsiyada Maal-gelinta

- Codsiyada ka yar \$50,000: Qorshe ganacsi oo dhamaystiran **AMA Buuxinta Su'aalaha Ganacsiga**
- Haddii aad hadda haysato ama aad heshiis ijaar u haysan doonto mid ka mid ah goobahaaga ganacsi ee liiska ku qoran, bixi nuqul ah heshiiska/heshiisyada kirada
- Haddii aad ku iibsanayso lacagta maalgelintan mashiin/makiinado ama qalab, ku dar liista iyo rasiidyada alaabta la iibsanayo
- Haddii aad iibsanayso ganacsi ama hanti ma-guurto ah, ku dar libashada iyo libka

Amaahda Dhismaha ee Kaliya

- Caddaynta xakamaynta goobta (tusaale, warqada lahaanshaha aaminaadda, lahaanshaha hadda, heshiiska iibsashada iyo iibka, ama, xaaladaha qaarkood, heshiiska kirada)
- Sharaxaad kooban oo qeexaysa qorshahaaga naqshadaynta iyo dhismaha, aqoonsanaya naqshadeeyayaasha iyo qandaraaslayaasha aad doonayso inaad isticmaasho, oo uu la socdo nuqullo ah wixii qandaraasyo ama soo jeedin ah
- Haddii aad doonayso inaad iskaa u maamusho dhismaha, bixi caddayn ah khibradahaagii hore
